### ***Please Note:***

- *Hillsboro Civic Center – 150 E Main St., Hillsboro, OR.* There is a 4 hour lot located at NE 2<sup>nd</sup> and Lincoln Streets. We encourage you to take the light rail from Washington County Fairplex, Tri-Met (blue line), with stops at 3<sup>rd</sup> Ave, or Hatfield Station. There is a \$2.50 fee each way.
- *The Hillsboro Field Event is one day only however you may attend the day prior starting at 12:00 pm for Recertification.*
- *The Lake Sammamish Event is one day only.*
- The State Park requires a Discover Pass in order to park on State Park grounds. Discover Pass fees are \$11.50 per day or \$35 per year, plus dealer and transaction fees, and may be purchased at the park entrance. NOC is not responsible for participant parking fees. NOC encourages ride-sharing. Park & Ride facilities are also located nearby.
- ***RECERTIFICATION TESTING WILL BEGIN AT 9 A.M. AND CONCLUDE BY 2:00 P.M.*** If you are unable to arrive at any Event by 12 noon please contact our office by phone 509-834-2050. Or contact Mark Edler @ 509-834-3425
- ***Please bring a clipboard and a pen with you.*** A chair, cap and rain gear are recommended. Events will be conducted regardless of weather.
- NOC will provide EPA Method 9 recertification only. This allows opacity readings to be made under EPA Method 9 and Washington State Department of Ecology Methods 9A and 9B

## Program Details

### MUTUAL LIABILITIES:

Registration and participation in any NOC event constitutes liability for payment, whether or not the candidate is successful in his or her attempt at Opacity Certification. Every attempt will be made by NOC staff to offer reasonable opportunity to each and every candidate for certification success, barring acts of God, extreme weather conditions, equipment failure or other conditions which are beyond the control of NOC staff members. In such situations, should NOC be unable to complete the Opacity Certification testing as scheduled, compensatory arrangements will be made with the client(s).

### YOU PAY ONLY IF YOU ATTEND:

We no longer issue refunds, or carry credits to the next season. You, or your organization, will be invoiced for those who attended following the event. NOC no longer accepts early payments. We now accept credit cards for payment, or you may pay by check. Make checks payable to YRCAA/NOC.

### SECONDARY TESTING:

If a registrant fails to certify during his or her testing event, he or she may attend any of the subsequent testing events in the *same season* (either Spring or Fall, in either WA or OR) at no additional charge.

### SUBSTITUTION:

Another person may attend in the place of a person who has pre-registered provided the name of the substitute is submitted prior to the beginning of an event.

### MULTIPLE CERTIFICATIONS:

Multiple certifications are available for those who wish to be certified using devices such as sunglasses or binoculars. A \$25.00 certificate fee is charged for each additional certification.

### WALLET CERTIFICATION CARDS:

Wallet-sized certification cards will be sent to each person that certifies.
